**Matthew R. Anderson** is a pastor of the Eastern Synod, ELCIC, and an affiliate professor at the Department of Theological Studies at Concordia University Montreal, as well as a Fellow of Loyola College for Diversity and Sustainability, also at Concordia. His recent research has focused on: Paul as pilgrim (presented at Århus, DK, in summer 2017); the make-up of Paul's congregation in Corinth with particular reference to the relationship between Jewish and non-Jewish followers as reflected in Paul's rhetoric (CSBS, May 2017); changes to European pilgrimage during the Protestant Reformations; and the walking of, and research into, Indigenous trails in Canada, especially as acts of 'dark pilgrimage' for descendants of settlers under the guidance of First Peoples. **Sunder John Boopalan** completed his Ph.D. in Religion and Society at Princeton Theological Seminary. His book, *Memory, Grief, and Agency: A Political Theological Account of Wrongs and Rites* (Palgrave Macmillan, 2017), is the outcome of his tenure at the Episcopal Divinity School, Cambridge, where he served as a Postdoctoral Fellow. Located broadly in the field of constructive theology, Boopalan's inter-disciplinary research addresses themes and concerns in political theologies and theological ethics. With strengths in the area of Dalit Christianity and interests in redressing structural wrongs, Boopalan draws from anthropological and ethnographic data particularly pertaining to caste and race.

**Allen G. Jorgenson** is Assistant Dean, Professor of Systematic Theology and holds the William D. Huras Chair in Ecclesiology and Church History at Waterloo Lutheran Seminary, Waterloo, ON, Canada. This essay is an edited version of a paper read on September 5, 2014 at a conference organized by the Department of Theological Studies of The Lutheran World Federation, which was held at The Lutheran School of Theology, Chicago. The author was asked to address the topic of "the theology of the cross in Canada and the crucifixion in the Gospel of Matthew."

**Daniel Maoz** (Strasbourg 1986) is Jewish Scholar in Residence and Professor of Hebrew Scriptures at Waterloo Lutheran Seminary. He is also a research associate at Concordia University, Montreal and Vice President of the Canadian Society for Jewish Studies.

**André S. Musskopf** is a Professor and Chair of Theology and Gender at the Graduate Program in Theology, part of the Coordination of the Gender and Religion Program and leader and researcher of the Gender Research Group at Faculdades EST. Musskopf has a Bachelor's Degree (2001), a Master's Degree (2004) and a Doctorate (2008) in Theology from Faculdades EST.

**David Pfrimmer** is the former Principal Dean and currently Professor Emeritus for Public Ethics at Waterloo Lutherans Seminary. Dr. Pfrimmer is a Senior Fellow at WLS's Centre for Public Ethics on the campus of Wilfrid Laurier University and an International Fellow at the Chester Ronning Centre at the University of Alberta. David was engaged in public policy and social justice work with the Canadian churches for close to twenty five years. His most recent books include *The Art of Dying Well - Medical Assistance in Dying in Canada* and *Faith in the Public Commons Pursuing the Common Good*.

**Vítor Westhelle** is professor of systematic theology at the Lutheran School of Theology at Chicago. Born in Brazil and ordained in the Lutheran church in Brazil he was the Coordinator of the Ecumenical Commission on Land in Paraná where he was an enabler and a companion with those struggling for land and justice. Westhelle is a well-known author with thirteen books and over 150 articles. His latest book, *Transfiguring Luther: The Planetary Promise of Luther's Theology* and his writings on Luther, Liberation, Creation, the Apocalyptic, Postcolonialism and Eschatology are widely acclaimed.

**George Zachariah** serves the United Theological College, Bangalore, India as professor of Christian Ethics. His publications include *Alternatives Unincorporated: Earth Ethics from the Grassroots* (London: Equinox Press, 2011), *Disruptive Faith, Inclusive Communities: Church and Homophobia* (ed.)
